This agreement is made this \_\_\_\_ day of \_\_\_\_\_, 2025, by and between Vitality Ageless Center, LLC dba VAC Wound Care and \_\_\_\_\_ (Practitioner).

TERMS OF AGREEMENT

Vitality Ageless Center, LLC dba VAC Wound Care will provide wound care patients to the practitioner with specific instructions of the approved protocol of treating the specific wound. Practitioners will be visiting homebound patients at the patient's home for wound care treatments. Practitioners may also be required to treat in nursing homes, personal care homes, assisted living facilities, and collaborate with home health agencies.

Practitioner must be credentialed with Medicare or be willing to get credentialed with Medicare. It is favorable for practitioners to be credentialed with other payers.

All training will be held at Vitality Ageless Center in Suwanee, GA or the location you are affiliated with, prior to any practitioner performing wound care treatments. In addition, there are video trainings in our practitioner portal with exams that practitioners will be expected to complete. Practitioners will be responsible for following the protocols provided by Vitality Ageless Center.

The patient's Medicare benefits are pre-authorized before being treated. After the initial visit, patients cannot receive further care without written authorization from VAC Wound Care.

Vitality Ageless Center – VAC Wound Care will provide practitioners with patients who are in need of care. When a practitioner agrees to accept a patient for care, they will be responsible for scheduling the first visit to see that patient within 48 hours of receipt of the patient's information and notify their manager of the date of first visit. If for any reason the patient cannot be reached, it's important that the practitioner keep their manager in the loop so that they can attempt to gain additional contact information for the patient.

Within 24 hours of the initial visit, Practitioner will provide a care plan and/or notes to management for home health or other caretakers to follow within 24 hours of each patient visit. Practitioners will also complete proper soap notes using the VAC Wound Care templates according to the MAC region they practice in after every treatment, as well as provide pictures with clear wound measurements, patient paperwork and identification, proper testing (bloodwork and other tests as needed), and a completed IVR.

After the initial visit, VAC Wound Care will work to obtain insurance authorization for a plan of care according to the patient's Medicare benefits, order approved products, and will notify practitioner of the care plan.

Vitality Ageless Center will bill all wound care treatments through their medical biller for the patient treated if using Vitality Ageless Center's credentials or practitioner will be tied to the proper NPI Group # for the state they treat patients. Nothing can be billed nor paid without soap notes.

Practitioner will receive pay as follows:

Prior to completion of training and/or receipt of wound care certification:

One-time fee of \$125 for the initial assessment of a patient. No further care can take place until the insurance verification (IVR) is submitted, and a care plan is approved. Paperwork and soap notes must be completed on the date the patient was seen. For treatments and care plans approved, or if a practitioner performs an additional approved visit, then a payment of \$100 will be made. This is outside of any membrane being placed. Practitioners will receive \$100 per visit for all approved Medicare Advantage and commercial payer membranes used or \$250.00 per visit for all Medicare Part B approved membranes in the patient's chronic wound care treatments.

If wound care certified or after completing training and exams on the VAC Practitioner Portal or directly with Ricko Rask:

One-time fee of \$125 for the initial assessment of a patient. No further care can take place until the insurance verification (IVR) is submitted, and a care plan is approved. Paperwork and soap notes must be completed on the date the patient was seen. For treatments and care plans approved, or if a practitioner performs an additional approved visit, then a payment of \$200 per visit will be made. This is outside of any membrane being placed. Practitioners will receive \$200 per visit for all approved Medicare Advantage and commercial payer membranes used or \$500 per visit for all Medicare Part B approved membranes in the patient's chronic wound care treatments.

Practitioner will be solely responsible to carry their own general liability insurance policy. VAC Wound Care will provide malpractice insurance for the practitioner.

Practitioner must have and maintain a current medical license from the state that they wish to practice.

Both parties agree to the terms of this contract.
